He is associated with the Mediation movement since its initial stages in 2002-2003 at the Bombay High Court and has undertaken a special tour of several Courts in California, USA to study their ADR & Case Management system.

Being a trained mediator, Shri M. P. Rao has mediated numerous disputes referred to him by the Bombay High Court. As a Senior Counsel, he has a vast experience in commercial disputes – how to avoid them as well as how to have them adjudicated or resolved. He shall be bringing together all of these varied experiences to shed light on the way forward for efficaciously resolving commercial disputes under the new regime of ***Pre-Institution Mediation*** introduced by the *Commercial Courts Act of 2015, as amended in 2018*.
