Overview of General Barriers to FDI in Hungary:

Regulatory barriers and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The Metropolitan Court for a review of the prohibiting decision.

Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. Gov't abolished price cap on fuel: With the abolition of the Ft 480 per litre price from 6 Dec, drivers will again pay the market rate for fuel, currently at Ft 617 per litre for gasoline and Ft 681 for diesel. PM Office leader Gergely Gulyás said Hungarian oil and gas company MOL had informed that it cannot ensure the country's fuel supply without imports. He blamed the shortage on the EU oil sanctions that came into effect on 05 Dec 2022, from which Hungary is exempt. He said the supply situation may return to normal in one to one and a half months, as it will take a few more weeks before the importers return to the old system. The price cap was introduced originally to ensure citizens can buy fuel at reasonable prices while curbing inflation, but since this fixed price was much lower than the market price, it led to supply problems with several retailers deciding not to sell at a loss while MOL could not meet the demand. At the same time the government has extended the food price freeze on staples until April 30.
- 2. Inflation hits 26-year high of 22.5% yr-on-yr in December, its highest level since August 1996 and exceeding the 22% consensus of analysts the Central Statistics Office (KSH) said. Food prices rose at the fastest pace in Europe, up 43.8% year-on-year, as the price of bread jumped up by 81.8%, egg prices rose 102.9% and dairy products were 79% more expensive. Household energy prices were up 65.9%, lifted by reduced government subsidies from August 1. Natural gas prices soared by 124.3% and electricity prices climbed 28.3%. Growth in prices of consumer durables was below the average, but well above the long-term average, up 14.4% year-on-year. As the reinstatement of market prices for vehicle fuel is expected to boost the headline figure by 2-2.5%, inflation could peak at 26% in January 2023.
- **3. Gov't raises energy sector tax to 41%:** The government has increased the so-called Robin Hood tax, levied on energy companies, from 31% to 41%, effective January 1 2023.. This tax, launched in 2008, is levied on energy companies, officially to make district heating more competitive. In effect, energy companies paid an income tax of 40% (9% corporate tax and 31% special tax, which has now been raised to 50%.
- **4. Industrial output growth slowed to 5.9% yr-on-yr in September**, and 5.1% higher when adjusted for working days, the KSH said. On a monthly basis, output fell by 3.5%. The automotive industry, which has the largest weight in the manufacturing sector, rose by 32.1% yr-on-yr from a low base. Computer, electronics and optical equipment segment, accounting for 11% of manufacturing, was 20.1% higher. However, output of the food, drinks and tobacco segment, which made up 13% of all manufacturing output, fell by 1.1%. Industrial output in the first ten months was up 6.6% yr-on-yr.

1		Liquidation of Dunaferr ordered	The Capital Court ordered the liquidation of the ISD Dunaferr steelworks, as soon as the relevant government decree entered into force. The decree, published on 13 Dec in the Magyar Kozlony, does not name Dunaferr, but provides an opportunity to start the liquidation of the struggling company, and may make it possible for a new investor to save the steelworks. The Economic Development Ministry previously confirmed that British-Indian group Liberty Steel is interested in the Dunaujvaros factory as a customer. The management of Dunaferr, which has been close to bankruptcy for a long time, still hoped for Ft 12 billion (EUR 30 mln) in government assistance.

The plant will turn out munitions for Lynx infantry fighting vehicles in the first phase, then for Leopard 2A7HU and PzH 2000 HU vehicles from 2024. Rheinmetall CEO Armin Papperger said the plant will supply ammunition for fighting vehicles being produced by Rheinmetall in Zalaegerszeg in line with the government's strategy. The German defence group will in future supply Hungary with an arsenal of infantry fighting and armoured fighting vehicles, artillery pieces and smoke grenade launchers.
5		Foreign investment record broken	Some €6.5 billion in foreign direct investment arrived in Hungary in 2022, which is a new record high, with more arriving from the East than the West, Foreign Affairs and Trade Minister Peter Szijjarto announced. Of these investments, 48% came from the East, 42% from the West and 10% from domestic sources. Most of the investments, 73%, were made in the electric car industry, and 43% in battery production alone. "Hungary has become the European champion of the transition to the electric car industry", he declared. The food sector attracted 10% of the investments and 8% went to service centres.

- 1. National Bank boosts inflation forecast for 2023: The MNB has increased its forecast for average inflation in 2023 from the 11.5-14% projected in Sept to 15-19.5%. GDP growth for 2023 is estimated at 0.5-1.5%. The government announced a 15% pension increase, indicating that it expects inflation to be near that level next year. Compared to the earlier report, the MNB raised its inflation forecast for 2022 from 13.5-14.5% to 14.5-14.7%, and expected GDP growth from 3-4% to 4.5-5%. Expected GDP growth for 2024 is 3.5%-4.5% with annual inflation rising to 23-26% at the beginning of 2023, up from 22.5% in Nov, which will then shrink back to the 3% medium-term inflation target by the beginning of 2024.
- **2. Hungarian wages second lowest in EU:** The average adjusted annual wage in Hungary was €12,600, the second lowest in the EU, according to the 2021 data released by Eurostat. The lowest average wage, of €10,300, was measured in Bulgaria, while Romania came third from bottom with €13,000. The highest average, of €72,200, was recorded in Luxembourg, followed by Denmark at €63,300 and Ireland at €50,300. The adjusted annual average wage of full-time employees was €33,500 in the EU last year, according to Eurostat.
- **3. Windfall tax imposed on drug makers and increased tax for insurance companies:** The government decreed a windfall tax on drug makers. The tax is 1% on the first Ft 50 billion (appx EUR 125 mln), and 3% on revenues of Ft 50-150 billion (appx EUR 125-375 mln), rising to 8% for revenue above Ft 150 billion (appx EUR 375 mln). The tax on 2022 revenues must be paid by May 20, 2023. An advance tax payment on revenues for 2023 must be paid by November 20, 2023. The progressive tax is payable on pharmaceutical companies' revenue for 2022 and 2023. The windfall tax on insurance companies was increased in the highest tax brackets of revenues of Ft 36 billion (appx EUR 90 mln) or more from 7% to 12% effective from 2023. In addition, the tax on revenue from insurance premiums exceeding Ft 36 billion (appx EUR 90 mln) will rise from 3% to 5%. Insurance companies are already paying approximately Ft 170 billion (appx EUR 425 mln) in windfall taxes annually,

Tariff and Non-Tariff Barriers to Trade:

import Tariffs: The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia's four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca,

Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

1. Increase in Consumer prices in BiH at 17%: measured by the consumer price index on October 2022 compared to the same month last year, annual inflation grew by an average of 17.4 %. Food and non-alcoholic beverages in October were more expensive by 25.9 %, transportation by 25.8 %, housing and overhead expenses by 22.9 %, restaurants and hotels by 11.6 %, furniture, household appliances and regular house maintenance by 11.4 %, recreation and culture by 11.3 %, alcoholic beverages and tobacco by 2.7 %, education by 2.3 %, healthcare by 2 %, communications by 1.4 %, and other goods and services by 7.8 %. Clothing and footwear were on average cheaper by 6.7 %, according to data from the BiH Statistics Agency. Consumer prices in October compared to September this year recorded an average growth of 2.1 %.

- 1. EU grants Bosnia and Herzegovina candidate status: The European Council voted on 15 December to grant Bosnia and Herzegovina EU candidate status, following a recommendation by the European Commission in October and votes in the EU Council and General Affairs Council. Joining the political and economic community of European states, along with joining NATO, is considered one of the most important political goals of BiH. The European Union recognized Bosnia and Herzegovina as a potential candidate since the decision of the European Council and the session held in Thessaloniki in 2003. BiH officially applied for membership in 2016. However BIH still needs to implement 14 priority reforms in order to continue the path toward EU membership. Among those priorities are ensuring that the elections are conducted in accordance with European standards, improving the functioning of the judiciary, strengthening the fight against corruption and organized crime, establishing effective coordination of border management, strengthening the protection of human rights, guaranteeing freedom of expression and the media, improving the protection of vulnerable categories of society and ensuring the completion of public administration reforms.
