ENFORCEABILITY OF ARBITRATION AGREEMENT WHICH IS NOT STAMPED

After the talk by the Speaker, time permitting, there will be a short 'Q & A' (Question & Answer) session / interaction for participants.

Introduction of the Topic:

A bench of 3 judges referred to the 5 judge Constitutional Bench specific question premised on the proposition that arbitration agreement is not amenable to Stamp Duty. Also there appears to be an impression that there were dissenting opinions given by two judges raising serious doubts about the finality in the matter. The discussion will be around these two areas with focus on reaching a true understanding of the judgment. It is hoped that some clarity will be achieved on enforceability of unstamped arbitration agreement and what to expect when it is sought to be enforced.

About the Speaker:



Mr. Anant Shende is an Advocate, Arbitrator and a member of IMC's Arbitration Committee for the past several years and a respectable member of legal profession for more than four decades. Mr. Shende started his practice with stints with Late Mr. M. V. Paranjpe (Former Advocate General of Maharashtra), Late Mr. D. M. Popat (Sr. Partner of M/s. Mulla & Mulla and Craigie Blunt & Caroe) and Late Mr. Tehmtan Andhyarujina (Former Advocate General of Maharashtra).

Mr. Shende worked as Legal Executive with Walchand Group and exclusively for Hindustan Construction Company Ltd. as well. Thereafter, he settled down in the Chambers of Mr. Rohit Kapadia, Senior Advocate, before starting his independent practice.

In a sense, he can be said to be a pioneering member of the Arbitration Bar along with few others in India. Since 1992, he has worked almost exclusively as arbitration counsel and, also acted as an arbitrator in a few cases. He has lost count of the number of arbitrations and the varied subjects of dispute that he has handled since then.

He is closely connected with the subject of today's Webinar, being a subject on which he is perhaps frequently called upon to advice.

He is empanelled as an Arbitrator on IMC International Arbitration Centre (IIAC's) panel of arbitrators.
