Objective of the webinar & Introduction of the Topic:

The Arbitration Bar of India (ABI) was inaugurated on May 11, 2024, at the Bharat Mandapam, New Delhi. The need for a specialized arbitration bar in consonance with worldwide accepted practices was felt and discussed for a long time. ABI symbolizes a significant milestone in India's legal journey in the practice of arbitration, and with a focus on fostering excellence, ethics, diversity and best practices in arbitration. Much is expected of ABI in the times to come to bring unity in diversity and some uniformity.

This webinar is focused on how ABI can play a pivotal role in ensuring the growth and development of arbitration practice in India and globally, advocating for legislative reforms and fostering collaboration within the arbitration community. The webinar will also include discussions on how to ensure a more efficient, fair and equitable future of arbitration in India.

About the Speakers & Moderator:

Mr. Gourab Banerji is a Senior Advocate appearing in the Supreme Court of India and the President of the Arbitration Bar of India (ABI). He has appeared in varied cases before the Indian courts and in many domestic and international arbitration in India and overseas. He is an alumnus of Cambridge University (1986-1989), from where he graduated with First Class Honor's and has been practicing in India since 1990. As an Additional Solicitor General of India in the Supreme Court (2009-2014), he represented the Union of India in many sensitive and landmark cases.

Mr. Banerji has also been appointed *amicus curiae* by the Courts in several matters relating to land laws, international commercial arbitration, Supreme Court practice and procedure, as well as indirect tax. He is also an Overseas Associate at the Essex Court Chambers, London. Mr. Banerji has appeared as *amicus curiae* in NN Global (2023) 7 SCC 1 and in the Seven Judge Constitution Bench judgment in Interplay between Arbitration Agreements under Arbitration and Conciliation Act, 1996 and Stamp Act, 1899 in Re (2024) 6 SCC 1 which held *inter alia* that parties may be referred to arbitration despite an unstamped or insufficiently stamped agreement.

Mr. Shikhil Suri is a Senior Advocate, practicing before the Hon'ble Supreme Court, Hon'ble Delhi High Court, Hon'ble NCLAT/NCLT and other fora. His practice focuses on commercial litigation, dispute resolution, criminal law, and public causes.

He earned his Law degree and an LL.M from University of Mumbai and Certificate in Business & Public Policy from the University of Pennsylvania Law School & The Wharton School, US. He has practiced with the law firm of M/s. Mulla & Mulla in Mumbai and at an AMLAW 100 firm, Crowell & Moring in Washington DC in the field of litigation and dispute resolution.

He is a member of IMC Arbitration Committee, the former Co-Chair of India Committee of the American Bar Association, Section of International Law and the former Chapter Chair for India of the New York State Bar Association International Section and is actively involved in promoting ties and building bridges between Indian and legal communities worldwide.

Mr. Gautam T. Mehta is the Chairman of IMC's Arbitration Committee and Director of IMC International ADR Centre. He is known in the legal fraternity, practicing and appears as a Counsel in matters before Supreme Court of India, High Court at Bombay – Original and Appellate side jurisdictions, The Debt Recovery and Appellate Debt Recovery Tribunals - Mumbai; in matters relating to arbitration, property, banking, commercial and consumer disputes. Appears as Counsel in matters before Arbitral Tribunals. Appointed as Arbitrator in various matters by private parties since 2007, and also, by the High Court at Bombay. Did a short stint as a part time lecturer in Government Law College, Mumbai. Takes a keen interest in the spread of the practice of arbitration, and in dissemination of knowledge on arbitration.

Mr. Vyom D Shah is a Solicitor and practicing as a Counsel in the Bombay High Court. He is a member of IMC's Arbitration Committee and registered as an Advocate on Record with the Supreme Court of India.
