**Objective of the webinar & Introduction of the Topic:**

Evidence plays a crucial role in arbitration proceedings, helping the arbitral tribunal understand the facts of the case, assess the merits of the parties' claims and defenses, and render a fair and impartial decision. Parties have the opportunity to present oral and documentary evidence, call witnesses, and cross-examine opposing evidence to support their respective positions. The admissibility and weight of evidence are determined by the tribunal, based on principles of fairness, relevance, and materiality. Arbitral proceedings, however, are not bound by the strict rules of the Code of Civil Procedure and the Evidence Act (now the Bharatiya Sakshya

Adhinyam), though the 'principles' of the same may apply. The objective of the webinar is to discuss what these principles would be and what procedure must be followed while taking evidence in arbitration proceedings.

#### **About the Speakers & Moderator:**

**Mr. Justice G. S. Patel** is a graduate of St. Xavier's College and Government Law College. He started practice in 1987 in Mumbai, working on commercial, corporate and civil litigations and also appearing in a large number of environmental public interest litigations including those relating to the Sanjay Gandhi National Park, protection of mangroves, town and country planning issues, Melghat National Park, the Mill Lands, protection of open spaces, etc.

In 1994-1995, Mr Justice Patel received the First international Fellowship at Pacific Energy & Resources Center, Sausalito, California in environmental law. This included course work at the University of Berkeley's Boalt Hall School of Law and an internship with the Sierra Club Legal Defense Fund.

He served as the Honorary Secretary of the Bombay Bar Association for two three-year terms from 1999 to 2005 and served on the Association's Standing Committee till his appointment as a High Court judge.

From 2008-2011 he was a part-time lecturer in Administrative Law, Constitutional Law and Environmental Law at Government Law College.

Mr. Justice Patel wrote a weekly newspaper column in the Mumbai Mirror for three years. He has also contributed articles to articles and reviews to the Economic & Political Weekly, TimeOut Mumbai, the Mumbai Reader, etc.

Mr Justice Patel has previously served as a trustee on several public charitable trusts and foundations in the fields of education, environment and the hearing-impaired. His served as a judge in High Court of Bombay was from year 2013 to 2024.

**Mr. Gautam T. Mehta** – is an Advocate, Counsel & Arbitrator. His areas of practice are as Counsel in civil and commercial litigations and in arbitrations (both as Counsel and as Arbitrator). He has conducted several arbitrations as arbitrator (appointed by parties or by court). His primary areas of practice are arbitrations, final hearings and trials. He has appeared as Counsel before courts (Bombay High Court, Supreme Court of India and City Civil Court at Bombay), DRT & DRAT, Tribunals, Fora, Commissions, etc.

Gautam delivers lectures and talks on arbitration law and practice at various institutions and bodies. He briefly assisted late Mr. D. M. Popat (Sr. Partner Mulla Mulla Craigie Blunt and Caroe) while Mr. Popat was working as part of consultation committee for drafting of the Arbitration & Conciliation, Act 1996.

Gautam is involved with IMC Chamber of Commerce and Industry (IMC) for almost 2 decades as member, Co-chairman and Chairman of its Arbitration Committee. He is one of the key persons' in devising and conduct of IMC's flagship event – the 7 Day Arbitration course held annually for the past 18 years and, its other activities including webinars and seminars. He is a speaker at IMC's 7 Day Arbitration course. He, for the past several years, is also a member of IMC's Managing Committee. Presently, he is IMC's representative member to Indian Council of Arbitration (ICA). He has represented IMC before Parliamentary Committees on arbitration and mediation.

In 2016, Gautam was actively involved with others in drafting IMC International ADR Centre's (IIAC) Rules and Code for arbitration. He is empanelled on IIAC's Panel of Arbitrators.

Since the past few years, Gautam is actively involved as a director on IIAC's Board of Directors.

Gautam was a member of Bombay Bar Association's (BBA) Standing Committee. Since 2022, he is actively involved as a certified Trainer in BBA's Advocacy Training course (ATC) regularly held by BBA for young lawyers.

Gautam graduated from Narsee Monjee College of Commerce and Economics (N M College). He graduated from Government Law College (GLC). He joined and trained in M/s. Kanga & Company – Advocates & Solicitors for several years, whereafter he joined the Chambers of Sr. Advocate Mr. Rohit A. Kapadia as a junior for several years, before setting up his own chambers.
