# THE MAHARASHTRA STAMP (AMENDMENT) ORDINANCE, 2024: ITS RIPPLE EFFECT ON THE ARBITRAL PROCESS

To create awareness on various topics in arbitration law and its practice amongst the public and stakeholders in arbitration (parties, lawyers and arbitrators), IMC's Arbitration Committee organizes knowledge series webinars from time to time.

The Maharashtra Stamp (Amendment) Ordinance, 2024 which was enacted on October 14, 2024, is a piece of legislation that aims to modify and update the Maharashtra Stamp Act, 1958. This amendment introduces several important changes to the existing law which primarily deals with the regulation of stamp duty in the state of Maharashtra. One of the most notable changes is the substantial increase in stamp duty rates for various instruments, including arbitral awards. The third webinar in this series focuses on a discussion of this Ordinance.
