1	Engineering Goods	In view of upcoming Infrastructure and energy projects including renewable Energy in Bahrain, there is a considerable scope to increase export of Engineering goods & project exports. There is export target of USD 233.9 million for engineering goods in FY 2024-25.
2	Pharmaceuticals (300220)	India's share in Bahrain's pharma market has remained less than 2% of its import. Patented medicines and foreign drug companies dominate the Bahraini pharmaceutical market. However, the generic drug sector is expected to grow as the government is looking to introduce mandatory health insurance scheme and control costs. This provides Indian pharma companies opportunity to make inroads in Bahraini market. Recognition of the Indian Pharmacopoeia (IP) taken up by the Mission and the proposed annex to the MoU in Healthcare Sector promote to promote trade of pharmaceutical products may help in boosting the pharma exports .
3.	Electronic Goods (including mobile phone)	Smartphones are the single largest export items from China to Bahrain which is the largest exporting country to Bahrain. Similarly, other electronic goods constitute important part of Chinese export basket to Bahrain. With India emerging as hub for Smartphones and other electronic goods , there is considerable scope to increase our export of these products to Bahrain. Last year (2023-24), we realized USD 157.3 million export under this category which is 1144% of export target of USD 13.8 million. This trend may continue with sustained efforts.
4	Jewellery of gold (71131910)	Gold jewellery is among top ten import items of Bahrain of which our share last year was only 11%. However, considerable amount of Indian jewellery is coming through UAE which captures 54% of Bahraini market. There is scope to increase our direct export to Bahraini market given popularity of Indian designs and craftsmanship.
5	Organic and processed food products	There is considerable scope to increase export of organic

		food, processed cereals, protein bars, healthy beverages, dairy products etc.
6	Textile Products	Indian textiles are known for their quality and diverse range , appealing to Bahraini consumers. Hence there is considerable scope to increase export of verity of textile products such as cotton fabrics, garments, home textiles synthetic fabric, carpets and technical textiles. The Mission is conducting a market survey on textile products/materials in Bahrain with an objective to increase export of textile products/materials from India to Bahrain. This survey will develop a better understanding for enhancing trade of textile products/materials from India to Bahrain.
7	Renewable energy products	Bahrain is actively working towards diversifying energy sources, with solar power especially expected to generate up to 1,300 MW by 2040. So there will be a considerable scope to increase the export of renewable energy products and related investments from India to Bahrain.

**(i) (Gulf Daily News 01.10.2024) Global rice prices decrease after India allows white rice exports:**

Global rice prices fell on 30.09.2024 after India, the world's No.1 exporter of the grain, gave the go-ahead for exports to resume, boosting global supply and helping poor Asian and African buyers secure more affordable supplies, exporters said. India on 28.09.2024 allowed exports of non-basmati white rice. That came a day after New Delhi cut export duty on parboiled rice to 10 per cent, buoyed by a new crop in the offing and higher inventories in state warehouses.

**(ii) (The Daily Tribune 04.10.2024) Bhutan inks huge renewable energy deal with Indian firm:**

Bhutan has signed a deal with India's Reliance Group to build 1,270 megawatts' worth of renewable electricity projects in the Himalayan nation as it seeks to become an energy-exporting powerhouse.

**(iii) (The Daily Tribune 05.10.2024) US, India to cooperate on critical minerals:**

The United States and India are set to work together on supply chains for critical minerals that are key to clean energy technologies, the US Commerce Department said on 03.10.2024 in a statement. US Commerce Secretary Gina Raimondo and India's Minister of Commerce and Industry Piyush Goyal met in the US capital Washington on 03.10.2024, inking a deal to "expand and diversify" critical mineral supply lines.

**(iv) (The Daily Tribune 06.10.2024) Business Conclave:**

BNI Bahrain hosted a high-profile Business Conclave at Gulf Hotel on 05.10.02024, welcoming a delegation of 46 Indian businessmen from BNI India. The event, aimed at fostering cross-border business collaboration, was graced by H.E. Mr. Vinod K. Jacob, the Ambassador of India to Bahrain, as the Chief Guest. Honorable Member of Parliament Dr. Hassan Bukhammas; Mr. P. Radhakrishnan Pillai, President of Bahrain Keraleeya Samajam; and Mr. Sudheer Thirunilath, the Director World NRI Council, Bahrain, were also in attendance.

**(v) (The Daily Tribune/Gulf Daily News 10.10.2024) All roads lead to strengthening Bahrain-India investments:**

Embassy of India, Bahrain, along with Bahrain India Society (BIS), organised an event titled "Focusing on Bilateral Investments" on 09.10.2024 at Crowne Plaza, Manama. The program was attended by H.E. Mr. Abdulla bin Adel Fakhro, Minister of Industry and Commerce, and representatives from BIS and the Indian and Bahraini Business communities. At the inaugural ceremony, H.E. Ambassador Vinod K Jacob conveyed that India-Bahrain bilateral relationship is very close and forward looking in 2024.

**(vi) (Gulf Daily News/ The Daily Tribune 16.10.2024) Indian minister in rare visit to Pakistan for SCO forum:**

Indian Foreign Minister Subrahmanyam Jaishankar arrived in Pakistan ON 15.10.2024 for a Shanghai Cooperation Organisation (SCO) summit, the first top Delhi diplomat to visit their neighbour in nearly a decade.



**(vii) (Gulf Daily News 18.10.2024) Hyundai India’s \$3.3 billion IPO oversubscribed on final day:** The \$3.3-billion IPO of Hyundai Motor India, the country’s largest yet, was fully subscribed on its final day on 17.10.2024, as big institutional investors bid aggressively, though pricing concerns deterred retail investors.

**(viii) (The Daily Tribune 18.10.2024) India’s Infosys bumps growth forecast on high client spending:** Indian IT giant Infosys raised its annual growth forecast on 17.10.2024 for the second time this year after recording a 4.7 percent on-year rise in net profit for the September quarter. The results indicate a steady increase in client spending at India’s second-largest software services exporter, which earns more than 80 percent of its revenue from Western markets.

**(ix) (The Daily Tribune 20.10.2024) Malabar Gold & Diamonds unveils its flagship showroom in the USA at Los Angeles:** Malabar Gold & Diamonds, the 6th largest jewellery retailer globally with over 360 showrooms across 13 countries, has launched its flagship showroom in the USA at Los Angeles. Marking a major milestone in the brand’s growth journey in North America, the new showroom will be Malabar Gold & Diamonds’ 5th and largest showroom in the USA.

**(x) (Gulf Daily News 23.10.2024) India’s cotton output ‘could fall by 7.4pc’:** India’s cotton production in 2024/25 is likely to fall by 7.4 per cent from a year ago to 30.2 million bales because of lower area and as excessive rainfall damaged the crop, a leading trade body said on 22.10.2024. Lower production will reduce exports from the world’s second biggest cotton producer in the current marketing year started on October 1 and force the country to increase imports, supporting global prices.

**(xi) (The Daily Tribune 29.10.2024) Bahrain Pushes for New Radio Opportunities with Fresh Bid for Indian Channel 87.6 MHz:** Bahrain’s vibrant radio scene is set to grow as the Tender Board invites bids for the operation of 87.6 MHz, an Indian entertainment channel that will run 24/7, building on the nation’s commitment to cultural inclusivity. This follows the recent awarding of 107.2 MHz to GO ALIVE MEDIA HOUSE W.L.L, which secured a bid of BHD 666,666 and is gearing up to provide Indian-focused programming over the next five years.

**(xii) (The Daily Tribune 30.10.2024) India Festival kicks off at Al Jazira Zinj Supermarket:** The vibrant India Festival 2024 has officially commenced with a grand inauguration ceremony held on 29.10.2024 at the Al Jazira Zinj Supermarket. The festival, which celebrates the rich culture and traditions of India, will run from October 29th to November 10th, 2024. The festival was inaugurated by the Chief Guest Vinod K. Jacob (Ambassador of India to the Kingdom of Bahrain) alongside distinguished guests including Abdul Rahman Juma (Chairman, Bahrain India Society), Prof. Dr. Nandita Sengupta (Head of IT Dept, University College of Bahrain), V K Thomas (Chairman, ICRF Bahrain), Abdul Hussein Khalil Dawani (Chairman - Al Jazira Group), Ujjal Kumar Mukherjee (CEO - Al Jazira Group).
