1. (Gulf Daily News 01.03.2024) India's GDP growth accelerates to 8.4pc: India's economy grew 8.4 per cent in the December quarter, official data showed on 29.02.2024, with a surging manufacturing sector helping defy more modest analyst forecasts. The world's most populous country is already among the best-performing economies thanks to robust domestic demand and investment.

2. (Gulf Daily News 03.03.2024) Google restores all delisted Indian apps: Google has restored all the delisted apps after India's Minister of Electronics and IT Ashwini Vaishnaw's intervention. Google on 02.03.2024 restored Indian applications like Bharat Matrimony and Naukri that it had delisted from its Play Store over a disagreement regarding service fee payments. The development comes hours after India strongly opposed the tech giant's move stating that the delisting of Indian apps cannot be permitted and that the startup ecosystem is key to the Indian economy and their fate cannot be left to any big tech to decide.

3. (Gulf Daily News 03.03.2024) WTO extends digital tariffs ban: World Trade Organisation (WTO) negotiators failed to break a deadlock on major reforms despite talks extending deep into overtime in Abu

Dhabi, in what some delegates said was a triumph of national interest over collective responsibility. Talks ended on 02.03.2024 after five days of negotiations which failed to see breakthroughs on agriculture, fisheries and other key topics. However, a moratorium on imposing tariffs on e-commerce data transmissions was extended by two years, in a relief to businesses. India, along with South Africa, had opposed extending a moratorium on digital trade tariffs – a move that has over-whelming support of most governments and from business – but later relented after an appeal from host UAE.

4. (Gulf Daily News/The Daily Tribune 09.03.2024) India to invest \$1.2 billion in AI projects: India will invest \$1.2 billion in a wide range of artificial intelligence projects as the world's most populous country stakes a claim to the burgeoning sector. The funds will be used to set up computing infrastructure and help finance AI startups, a statement from the information technology ministry said late Thursday. Junior Minister Rajeev Chandrasekhar said the investment “will catalyse India's AI ecosystem and position it as a force shaping the future of AI for India and for the world”. India's nascent AI market will be worth \$17bn by 2027, according to current forecasts by local IT industry body NASSCOM.

5. (The Daily Tribune 09.03.2024) India-Nepal enhance financial cooperation; digital payment to be inaugurated soon: Nepal's Ambassador to India, Shankar Sharma on Saturday appreciated the new guidelines of the Reserve Bank of India, which allow multiple financial services between the people of India and Nepal. RBI's updated regulation allows Nepali account holders to send INR 2 lakhs per transaction (without any limit) to. Walk-in customers can remit Rs. 50,000 per transaction (12 per yr).

6. (Al Bilad 09.03.2024) India allows onion exports to Bahrain: The Indian government has notified to allow the export of 3,000 tons of onions to Bahrain, 1,200 tons, to Mauritius and 550 tons to Bhutan, through the National Cooperative Exports Limited. Last year, the government imposed a ban on onion exports until March 31 to meet local demand and stabilize wholesale prices, but it allows a specific amount to be exported to friendly countries, according to the economic times website.

7. (Gulf Daily News/The Daily Tribune/BNA 10.03.2024) India signs key pact with Europe trade group: India will lift most import tariffs on industrial products from four European countries in return for investment of \$100 billion over 15 years, its trade Minister said, after an economic pact signed on 09.03.2024 that concluded nearly 16 years of negotiations. The deal follows trade pacts over the last two years with Australia and the UAE, while officials say a another, with Britain, is in its final stages, as Prime Minister Narendra Modi aims for annual exports of \$1 trillion by 2030.

8. (Gulf Daily news/BNA 13.03.2024) India and Britain reaffirm commitment to trade deal: Indian Prime Minister Narendra Modi and British counterpart Rishi Sunak reaffirmed their commitment to securing a new trade deal in a call yesterday, as the prospect of an agreement ahead of elections in India fades. Britain and India have held stop-start talks over a Free Trade Agreement (FTA) for two years. Both countries are set to hold national elections in 2024.

9. (Gulf Daily news 13.03.2024) Wheat stocks hit seven-year low: Indian wheat inventories held in government warehouses dropped to 9.7 million metric tonnes, the lowest since 2017, after two straight years of low crops prompted the state to sell record volumes to boost domestic supplies and lower local prices. Wheat reserves in state stores totalled 9.7m tonnes at the start of this month, down from 11.7m tonnes in March 2022, the state-run Food Corporation of India said. Despite the tight supply, the government has resisted calls to encourage imports by cutting or removing the current 40 per cent tax, or by directly buying from top suppliers such as Russia.

10. (The Daily Tribune 19.03.2024) India, Singapore sign MoU for cooperation in law, dispute resolution: India and Singapore signed a Memorandum of Understanding (MoU) on cooperation between the two countries in the sphere of Law and Dispute Resolution on 14.03.2024. The Memorandum of Understanding was signed in a virtual meeting of the Minister of State for Law and Justice (Independent Charge), Government of India, Arjun Ram Meghwal for the Indian side and the Minister for Culture, Community and Youth and Second Minister for Law, Government of Singapore, Edwin Tong for the Singapore side.

11. (Al Bilad 20.03.2024) Includes former Ambassador to Manama Balkrishna Shetty, An Indian delegation will visit Bahrain soon to develop economic relations: A delegation from the Indian Economic Trade Organization will visit the Kingdom of Bahrain, during the period from 24 to 26 March, and includes 13 members of the organization, headed by the former Ambassador of the Republic of India to the Kingdom of Bahrain Balkrishna Shetty. Members of the delegation will meet with a number of officials and businessmen in the Kingdom of Bahrain, to discuss developing economic relations between the Kingdom of Bahrain and the Republic of India. In addition to Ambassador Shetty, the delegation includes the President of the Indian Trade and Economic Organization Asif Iqbal, and the Vice President of the Organization Wali Kashif.

12. (Al Watan/Akhbar Al Khaleej 25.03.2024) During a business meeting for the Indian Economic Trade delegation, Nass: India is likely to be the most powerful economy in the world: President of the Bahrain Chamber of Commerce and Industry confirmed that the Indian economy is now competing with the Chinese, American and Japanese economies, as India is considered one of the great countries in terms of employment and technology, and they have reached advanced stages, and we do not rule out that India will be the strongest economically in the world in the coming years, and this is what we expected 20 years ago and we are now seeing in reality. This came during a business meeting organized by the Bahrain India Society in partnership with the Bahrain Chamber of Commerce and Industry, for the delegation of the Indian Economic Trade Organization at the Al Tejar House, in the presence of the Minister of Industry and Commerce Abdullah Fakhro, the President of the Chamber, and the Chairman of the Board of Directors of the Association Abdul Rahman Juma.

13. (Al Bilad 26.03.2024) Delegation of 18 Indian companies visits the Kingdom, Indian businessmen: Promising investment opportunities in Bahrain: Indian businessmen said that Bahrain has investment potential in a number of vital sectors, such as aluminum industries, logistics services, transportation, in addition to food and other sectors. An Indian trade delegation held yesterday trade discussions with their counterparts on the Bahraini side at the headquarters of the Bahrain Chamber of Commerce and Industry, in the presence of the Minister of Industry and Trade, Abdullah Fakhro, the President of the Bahrain Chamber of Commerce and Industry, Samir Nass, and the President of the Bahrain India Society, Abdul Rahman Juma. The head of the Indian Economic and Trade Organization (IETO), Asif Iqbal, told Al-Bilad that the delegation includes 18 Indian companies from various commercial sectors in Indian cities.

14. (Gulf Daily News 22.03.2024) Saudi boosts maritime connectivity with India: Saudi Arabia's King Abdulaziz Port has strengthened connections to India's nautical hubs thanks to increased co-operation between two Gulf maritime bodies, reports Arab News. The Saudi Ports Authority announced that Safeen Co., a subsidiary of the Abu Dhabi Ports Group, has added the Dammam facility to its new UAE-India-Gulf service – a maritime trade route connecting India and the wider Arabian region. The passage serves as a vital artery for the transportation of goods and commodities between these key economic centres. It supports trade flows, facilitates supply chains, and contributes significantly to the economic growth and development of the areas it connects.

15. (Gulf Daily News 24.03.2024) India extends ban on onion exports ahead of elections: India has extended its ban on onion exports indefinitely – a surprise move that comes ahead of a general election and is set to exacerbate high prices in some overseas markets. Imposed by India – the world's biggest exporter of the vegetable in December, the ban was due to expire on March 31. Traders had anticipated it would be lifted as local prices have more than halved since the export restrictions were implemented and this season's crop is yielding fresh supplies. However, the government issued an order late on 22.03.2024 that the ban will remain in place until further notice. "The extension is surprising and completely unnecessary, considering the falling prices with rising supplies from the new season crop," said an executive at a Mumbai-based export firm.

16. (Al Bilad 25.03.2024) Nass: The free trade agreement between the Gulf States and India is in the

process of discussions: The President of the Bahrain Chamber of Commerce and Industry, Samir Nass, said that the free trade agreement between the Gulf States and India is in the process of discussions, stressing that the repercussions of this agreement on the Kingdom of Bahrain are very positive.

17. (Gulf Daily News 27.03.2024) India’s rice exporters face huge tax demand: India exporters have received notices from the customs department demanding payment of duty differentials on rice exported in the last 18 months, four exporters told Reuters, a rare tax demand that could cripple rice shipments from India. The world’s biggest rice exporter imposed a 20 per cent export duty on white rice in September 2022, followed by a similar duty on parboiled rice in August 2023 to control domestic rice prices ahead of key 2024 state and national elections. Exporters were paying a 20pc duty based on the Free on Board (FOB) value of rice. However, the customs department now requires them to consider the transaction value and pay any resulting duty difference. “It is informed to pay the export duty along with applicable interest by exporters on the amounts received over and above the FOB value declared in the shipping bills,” the customs department informed exporters, in tax demand notices seen by Reuters.

18. (Gulf Daily News 30.03.2024) India ‘keen on free trade deals with UK and Oman’: India Prime Minister Narendra Modi is likely to prioritise completion of free trade deals with Britain and Oman in the first 100 days of the next government if he wins upcoming elections as opinion polls predict, two government sources said. Modi has asked Indian ministries to set annual goals for the next five years that will fit into a 100-day action plan as he chalks out a strategy to fuel further growth in Asia’s third-largest economy.
