## **Overview of General Barriers to FDI in Hungary:**

**Regulatory barriers** and administrative burden are affecting all sectors but particularly energy, construction, and banking: The overall administrative burden, including start-ups, negatively affects investment decisions. The instability of the regulatory framework, with frequent and unpredictable regulatory changes, creates uncertainty for investors and is hindering both internal investment and FDIs.

The Hungarian government imposes a 100% offset requirement for defined sector investments over HUF 1bln (EUR 2.8 mln). Efficiency of procedures in construction and environmental permits is insufficient; corruption also raises risk for investors. There is no requirement that investors must purchase from local sources, but the EU Rules of origin applies.

## Ownership restrictions (all non-EU)

according to the 2014 Land Law, only private Hungarian or EU citizens resident in Hungary with a minimum of three years experience of working in agriculture or holding degree in agriculture can purchase farmland, which is limited to 300 hectares. All others may lease farmland. All farmland purchases must be approved by a local land committee and Hungarian authorities, local farmers and young farmers must be offered a chance to purchase the land first. Up to 1200 hectares for a maximum of 20 years may be leased.

Price controls in consumer facing sectors and others considered to be of strategic importance.

The Hungarian government regulates the prices of certain goods, setting the upper and lower limits to which the private sector must adhere. Sectors include energy, pharmaceuticals. Cuts on regulated utilities prices have put considerable pressure on private utilities companies, decreasing profit margins and adding to an increasingly difficult operating environment.

State intervention in Banking, energy, agriculture, media, telecommunications, and retail sectors.

Since 2012 government has invested in state-owned enterprises with the objective of lessening the participation of foreign-owned competitors, especially in the energy sector. From 1 Jan 2019, the chemical industry, the telecom sector, vehicle construction, metallurgy, optics and electric equipment production, the defence industry, water and sewage management, the financial sector, food industry and agriculture, production of construction materials, state administration, health care, wage management, transport and tourism sectors have been added. Foreign investors in the targeted sectors have expressed concerns that the tax regime has become unpredictable and the additional levies appear to have been aimed against some industries with a high level of foreign ownership.

## Basic Rules of The Protection of Strategic assets Concerning Foreign investments

The European Commission has issued Communication 2020/C 99 i/01 in which it has given guidance to the Member States of the EU concerning the protection of Europe's strategic assets from the foreign direct investment, ahead of the application of Regulation (EU) 2019/452 (FDI Screening Regulation) which is applicable from 11 October 2020.Commission Delegated Regulation (EU) 2020/1298 of 13 July 2020 amended the Annex to Regulation (EU) 2019/452.

Hungary first adopted FDI screening mechanisms by act LVII of 2018 for FDIs violating the security interests of the country, then in the economic crisis caused by COVID-19, further screening rules were adopted for FDIs by Government Decree nr. 227/2020. (V.25.). According to the above, certain transactions concerning Hungarian-seated companies operated in strategic sectors by foreign investors shall be reported to the Minister of Finance and the acknowledgement of the Minister of Finance is necessary for the realisation of the acquisition of the shares until 31 December 2020. These transactions include the acquisition of shares, the increase of the registered capital and the transformation of the company. The strategic sectors specified by the Government Decree include energy, communication, finance, agriculture and food industry, healthcare, construction, transport industry, tourism, IT, mechanical engineering, etc. Those foreign investors that have shares in a company registered in the EU, European economic Community or in Switzerland shall only report the transaction if majority interest will be acquired indirectly. Conversely, the foreign investors wishing to acquire shares in a Hungarian company directly have to report any transactions by which the foreign investor would acquire shares at a ratio of at least 10% and the value of the investment is at least 350 000 000 HUF (appx EUR 1 mln). The Minister of Finance has 45 days or in specific and duly justified cases 60 days to decide on the acknowledgement of the transaction. Should the Minister provide a negative decision, then the exact reason of the prohibition is not required to be mentioned. Aggrieved investor may appeal before The metropolitan Court for a review of the prohibiting decision.

## Banking, agriculture, defence and energy

The Hungarian government has publicly declared that reducing foreign bank market share in the Hungarian financial sector and tightening regulations governing NGOs are key priority areas. Several state-led initiatives over the past several years targeted the banking sector and reduced foreign participation.

- 1. The tourism sector achieved robust growth in October as arrivals were up 15.1% yr/yr to 1.5 mln and overnight stays increased by 8.5% to 3.4 mln. The growth was driven by foreign guests, who spent 1.8 mln nights at Hungarian accommodation, a 13% yr/yr rise. Overnight stays in the first ten months rose by 5.3% to 38.5 million, as domestic guests spent 1.9% more nights in commercial accommodation, and foreign visitors 9.0% more. Total revenue for accommodations reached Ft 91.5 billion last month, up 21% yr/yr.
- **2. Annual inflation reached 3.2% in October**, rising from 3.0% in the previous month, but below analysts' expectations of 3.5%, according to the Central Statistical Office KSH. The monthly increase was 0.1% and core inflation was unchanged. The easing of inflationary pressures is reflected in the decline in core inflation to 4.5% last month from 4.8% in September. One negative surprise was the steep rise in food prices, up 4.5% year-on-year, the largest annual increase so far in 2024. On a monthly basis, food prices went up by 0.7%. Repricing in the service sector was moderate in October as price growth decelerated from 8.4% in September to 7.2% due to the decline in mobile and internet subscription fees. Prices of consumer durables contracted by 0.3% yr/yr but edged up 0.1% m/m. Analysts warned of renewed inflationary pressure from potential price increases in food, fuel, and imported goods, especially if the forint's decline continues. MBH bank said it expects inflation to edge up to 4.4% at the end of the year and to average 3.7% for the year.
- **3. The European Commission has cut its GDP growth forecast** for Hungary for this year to 0.6%, a dramatic cut from the 2.4% estimated last February. The 2025 growth projection has fallen from 3.6% envisioned in February to 1.8%. Consumption will be the main driver for growth, the EC added. Inflation, although it will have fallen significantly in 2024, will remain high, as will the budget deficit, according to the analysis. The relatively high state debt to GDP ratio of 74.5% this year is partly due to the purchase of the Budapest Airport, and is expected to only fall to 73.8% in 2026. The budget deficit is forecast to drop from 6.7% of GDP in 2023 to 5.4% in 2024, 4.6% in 2025 and 4.1% in 2026.

Dunaferr becomes insolvent	The interim asset supervisor of Liberty Steels Hungarian unit initiated the procedure to tap the Wage Guarantee Fund after the companys owners signalled they have no available funds to pay the October salaries. This essentially means the insolvency of the company, Liberty Steel, owned by industrialist Sanjeev Gupta. The businessman acquired Dunaferr in 2023 after a liquidation procedure with a promise to turn around the troubled steelmaker. It planned a transition to green steel production, which would have required an estimated Ft 200 bln in funding. Dunaferr employed nearly 3,700 people, but had lost its environmental permits and had accumulated debts of around Ft 500 bln. Liberty Steel needs short-term support from the government and other stakeholders to restart production and manufacturing. If this is not possible, negotiations with potential new investors will also be considered, the company added.
	2	Jabil dismissing 500 in Tiszaujvaros	Jabil, one of the largest employers in Northern Hungary, has dismissed appx 500 workers from its factory in Tiszaujvaros in recent months, mainly due to the drastic drop in orders for electric car parts. The company told that several functions had been reorganised, which affected the number of employees at the unit.

The company executed site preparation and full infrastructure development, including the construction of the 140,000m2 manufacturing facility. The project involved significant groundwork, with 1.5 mln cubic metres of soil moved, and the establishment of other critical infrastructure such as a training centre and fire safety facilities. BMW laid the cornerstone of the plant in Debrecen in the summer of 2022 and production is set to start in 2025.
	4	MOL building EUR 40mn solar park	MOL subsidiary MOL Petrolkemia will invest EUR 40 mln in building a 48MW solar park at the units base in Tiszaujvaros, CEO Gyorgy Bacsa announced. The new solar park, situated on a 66-hectare tailings pond site next to an existing 6MW facility, will directly supply the petrochemical plant with green energy, meeting its growing energy needs, including demand from the new polyol plant in the city. The solar plant will meet about 5 percent of MOL Petrochemicals electricity needs, generating power equivalent to the annual consumption of 28,000 households and reducing carbon dioxide emissions by 17,000 tons annually. MOL currently operates five solar parks, including two at its refinery in Szazhalombatta, with a total capacity of 31.5MW.

- Windfall profit reduced for banks: The government has announced changes to the windfall profit tax, maintaining the rates for retail companies while lowering the levy for banks and increasing it somewhat for insurers. For banks the tax base is the pre-tax profit, subject to modification depending on other factors. From next year banks will be able to deduct part of their increased state bond investment for maturities beyond January 1, 2029. The new conditions encourage banks to increase their exposure to government securities even more than before, HVG notes. For insurers the tax is 3% on non-life insurance premium revenues up to Ft 48 billion, and 14% above it. This year the tax for non-life products was 2% up to revenues of Ft 2 billion, and 4% up to Ft 46 billion, rising to 12% for higher revenue. The tax is 2% on life insurance premium revenues up to Ft 48 billion and 6% above that.
- 2. Wage growth at 12.5% in September: The average gross wage was Ft 627,400 a month in Sept up by 12.5% from one year earlier, the KSH announced. The average net wage was Ft 417,200, also increasing by 12.5% yr/yr. The median value of gross wages came to Ft 519,500, a 15.5% rise from a year earlier, while the net median wage stood at Ft 359,100, up by 15.4%. Real wage growth was 9.2% in September from a year earlier, as inflation was 3%. In the first nine months, gross wages were up by 13.7% year-on-year to Ft 633,500, while the average net wage also expanded by 13.7% to Ft 421,300. Wages continued to grow significantly in September, although the rate of increase slowed slightly compared to previous month. However, due to low inflation, the real wage is rising rapidly.
- 3. Industrial output was 5.4% lower in September than one year earlier, according to the KSH. Unadjusted data show a 7.2% decline in industrial output. Both seasonally and workday adjusted figures show output shrinking by 0.7% from August to September. The performance of industry has not been so poor in four years. Output has been on a downward trend for two years, and it seems that a sudden rebound cannot be expected. Industrial export volume decreased by 5%, yr/yr while domestic industrial sales dropped by 2.9% in September. Output of the manufacturing sector, which represents a 96% weight within the industrial sector, was down 8.3%, that of the energy industry fell by 2.2%, while the output of the relatively small mining sector increased by 29%. Automotive sector production decreased by 11.4%. Within that category vehicle production fell by 14.8% and parts production was down by 8.5%. The production of electrical equipment, with a weight of 10% in the total, was 10.4% lower than a year earlier. There were declines of 11.6% in EV battery production, and 8.6% in the production of electric motors, power generators, and distribution and control devices.

## **Tariff and Non-Tariff Barriers to Trade:**

**import Tariffs:** The tariff rate on imports averages a comparatively low 1.1% of the value of goods (for international trade), which is the lowest figure regionally and third lowest figure in the whole emerging Europe region. Bosnia's import tariffs are harmonised each year with the combined nomenclature of EU and legislative regulations.

Anti-dumping and countervailing duties: in 2009 Bosnia introduced a law for the protection of domestic products against imports from Croatia and Serbia.

The law stipulates that safeguard measures were necessary owing to the influx of imports and the dumping of particular agricultural products from Croatia and Serbia, as well as a conceivable decrease in exports from Bosnia to Serbia.

Customs and Non-tariff Barriers: as a result of BiH not having EU member status event though the majority of its trading partners are EU member states, export and import supply chains will face more onerous border and documentary times and costs when compared with those of EU states.

The most salient risk is the high cost associated with import border compliance processes, which is higher than that of countries such as North Macedonia and contributes towards Bosnia's status as regional under performer in relation to customs burdens.

Businesses operating in BiH face a high import burden as infrastructural development, industrial capacity and diversification remains weak because of a dearth of fixed capital formation and a lack of political resolve in the country. Imports are driven by the country's need for complex machinery and its energy requirements, such as oil and gas, as well as metals and manufactured goods that cannot be produced locally.

To spur trade, Bosnia has exempted tariff payments from certain equipment that is being imported as part of share capital, with the exceptions of passenger vehicles and slot or gambling machines. To enjoy this benefit, foreign investors must submit a written request to the appropriate customs authority, along with evidence of the investment arrangement and registration of the foreign share. Alternatively, imports into one of Bosnia"s four free trade zones are exempt from customs duties and fees. These zones can be found at Vogosca, Visoko, Mostar and Holc Lukavac and clearly mitigate cost risks for businesses seeking to trade internationally with Bosnia.

Bosnia has applied to join the EU, and accession would open up trade, investment and growth opportunities for the economy. The country has already made good strides in establishing free trade and preliminary agreements to speed up the process of EU accession although, political instability threatens the prospect of EU membership in the medium term. Bosnia is also currently discussing the possibility of the creation of a Western Balkans Customs union with its South eastern-Europe counterparts.

1. Annual Inflation 0.9%: According to the BiH Statistics Agency, consumer prices in BiH recorded a monthly increase of 0.2% in October compared to September 2024. On average, the price of food and nonalcoholic beverages increased by 0.8%, alcoholic beverages and tobacco by 0.2%, clothing and footwear by 1.6%, healthcare by 0.5%, education by 0.4%, restaurants and hotels by 0.4%, and other goods and services by 0.3%. Lower prices on average were recorded for housing and overhead expenses by 0.8%, furniture, household appliances and regular home maintenance by 0.2%, and transportation by 0.2%. On an annual basis, in October of this year compared to October of 2023, an average increase in price levels was 0.9%. Food and soft drinks became more expensive on average by 3.4%, alcoholic beverages and tobacco by 4.5%, healthcare by 4%, communications by 0.2%, recreation and culture by 3%, Education by 0.4%, restaurants and hotels by 6.7% and other goods and services by 3.9%. The average decline in prices for clothing and footwear was by 7.9%, housing and overhead expenses by 1.1%, furniture, household appliances and regular home maintenance by 0.4%, and transportation by 6.6%.

1. BiH with EUR 157.5 mln for Energy Transition and Economy: During recent intergovernmental development cooperation talks between Germany and BIH in Berlin, Germany pledged substantial assistance totalling €157.5 mln. This funding, provided through a combination of favourable loans, grants, and technical cooperation, shall target projects in energy transition and sustainable economic development. Germany, through the German Development Bank (KfW), is supporting initiatives such as the construction of wind farms and the decarbonization of BiHs energy sector. Additionally, the German organization Gesellschaft fur Internationale Zusammenarbeit (GIZ) is assisting businesses and public services in areas like digitalization, vocational training, and the development of a circular economy. Germany will also champion good governance practices and support public institutions in their ongoing efforts to align with European Union standards.

- 2. India and Bosnia and Herzegovina held their 4th Foreign Office Consultations (FOC) in Sarajevo on 28 November 2024. The Indian side was led by Shri Arun Kumar Sahu, Additional Secretary (Central Europe), Ministry of External Affairs. The Bosnian side was led by Mr Tarik Bukvic, Head of Department for Asia and Africa, Ministry of Foreign Affairs of Bosnia and Herzegovina. During the FOCs, both sides undertook a comprehensive review of bilateral, regional and international issues. Discussions were focussed on progress made in political relations, trade and investments, cooperation in S&T, cultural relations and people-to-people contacts through students and youth exchange and promotion of tourism between the two countries.
